Biennial Convention July 25-28

Father Flanagan Dreamed of an Alumni Association

As far back as the early 1940s, Father Flanagan had a goal to form an active and formal Boys Town Alumni Association. This summer, July 25-28, 2013, will mark the 31st Biennial Convention of the Boys Town National Alumni Association®, and it promises to be a great weekend of reunion, renewal of friendships, and a return of alumni to the home of their youth.

During World War II, there was an informal alumni group, complete with a president who reported the whereabouts of various alumni during the war. Articles were published in the Boys Town Times about alumni in the different services and where they were stationed or fighting. Wherever Father Flanagan went in the world in support of the war effort, he was greeted by alumni who were serving in the military. Father Flanagan's dream of an alumni association went dormant upon his untimely death in 1948 while on a mission for President Truman to Germany. It wasn't until 1951, when Monsignor Nicholas Wegner, Executive Director of Boys Town, brought together a group of alumni and the Boys Town National Alumni Association was finally formed.

In 1952, the first reunion was held at Boys Town and subsequently scheduled for every odd-numbered year.

This year we will be celebrating the 50th reunion of the classes of 1962 and 1963. Members of both classes have been busy over the past year contacting

classmates and preparing to return to Boys Town to be honored for this milestone reunion by their fellow alumni. The classes of 1987 and 1988 will be celebrating their 25th reunion, and we look forward to their return.

Your BTNAA Convention Committee has arranged, for those who might arrive Thursday, July 25, the opportunity to go to an Omaha Storm Chasers baseball game with premium seating for only \$20. If you are coming with your family or are just a baseball fan, be sure to take advantage of this new event for the Convention weekend. Families arriving early also should plan on visiting the Henry Doorly Zoo in Omaha. It is one of the most-visited zoos in the country and boasts unique and interesting exhibits. For aviation buffs, the Strategic Air & Space Museum near Ashland, Nebraska, is a must visit. The exhibits are excellent and the collection of aircraft and missiles is impressive. Thursday evening will also see an informal pizza dinner, and also a dinner arranged by the 50-year reunion classes at a local Omaha restaurant.

Start your Friday morning off with breakfast at the Boys Town Visitors Center Café. With your Convention registration, you will receive a ticket for four meals (three breakfasts and one lunch) at the Visitors Center and one lunch on Saturday at the Great Hall (former

Alumni Profile

Robert "Bob" Johns, '63

Robert "Bob" Johns arrived at Boys Town on June 2, 1958, with his brothers Richard, '64, and Thomas, '66, from south Omaha. Their mother saw that Bob and his two younger brothers needed stability in their lives, and that Boys Town was the place where they could prosper.

"If I hadn't gone to Boys Town I would not have what I have today," Bob said. "Boys Town gave me the home life I didn't have and the ability to be able to be successful at things

I wasn't sure I could accomplish. My mom made a difficult decision at the time, but it was the right one for me. I am truly thankful to her for having the courage to send me to Boys Town."

Johns said he worked for Bob Erding at the Boys Town Bank as a teller, cashing checks and dispensing Boys Town currency residents could use in the student canteen and to buy clothes in the clothing store.

Upon graduation, and using his experience in the Boys Town Bank, Johns went to work at U.S. National Bank in Omaha. His blossoming banking career was interrupted from 1965 to 1968 as he served his country in the Army.

Upon returning to the states, he enrolled at

the University of Omaha, now the University of Nebraska-Omaha, and graduated in 1973. It was at this time that Johns resumed his banking career. Today, he is still in the banking business in Omaha.

Johns, the father of Johnna and Joel, and proud grandfather to Virginia, Emma and Josie, enjoys spending time with them, especially during the holidays. He says, "they bring me great joy as I grow older and they keep me young."

Johns has been working for the past year and a half organizing the 50th reunion for his Class of 1963. During this time, he has found a number of classmates and has worked tirelessly to keep them informed about their classmates and the upcoming reunion. He is hoping for a large turnout this coming July and has challenged his class to outdo the Class of 1962 in attendance.

"I believe I am the only person from Boys Town who arrived and graduated on the same day, June 2, five years to the day," Johns said. He is grateful for the support and education he received growing up. Without that foundation, he is not sure where his life might have led. Johns is a Lifetime Member of the Boys Town National Alumni Association®.

Three Boys Town Classmates from 1947 Celebrate Amazing 60 Years of Marriage

Too often, in today's fast-paced world, we find that commitment is an elusive trait. Not so for the following three members of the Class of 1947 who have celebrated, or are about to celebrate, their 60th wedding anniversaries.

William "Bill" Echols arrived at Boys Town from Birmingham, Alabama, at the age of 14 in 1943 with his brother, the late Robert Echols, D'46. Echols has fond memories of his days at the Home and lays claim to being the first boy from Alabama to graduate from Boys Town. After graduation, he worked for a short time as a file clerk in a Birmingham hospital before beginning his life work as a Senior Design Draftsman – a career at which he excelled for nearly 20 years prior to retiring in 1985.

His memories of Father Flanagan were the war-time memories most Boys Town boys had at the time. Father Flanagan was traveling a lot for the war effort and going overseas to help with the orphan problems in Europe and Japan. Like all the boys, Echols did meet with Father Flanagan and remembers this one important instruction given to him, "Get involved in church."

Echols did just that when he went back to Birmingham, and he became involved with the Catholic Youth Organization (CYO), where he met his future bride, Eloise. They dated for five years and were married on January 17, 1953. Bill and Eloise celebrated their 60th anniversary this past January in Birmingham. Bill shared his secret to 60 years of successful marriage: "remain committed to each other and do what you both promised you were going to do when you got married."

When asked what advice he would give to current Boys Town youth, he

replied, "be obedient to what you learned at Boys Town." Echols is a Lifetime Member of the Boys Town National Alumni Association.

The Echols have seven children, 14 grandchildren and six great-grandchildren.

Joseph "Joe" Ortega arrived at Boys Town from Kansas City, Missouri, in 1943 as a somewhat defiant street kid from the big city. He quickly changed his tune when he figured out Boys Town wasn't a reform school and Father Flanagan wasn't the warden. While at Boys Town, Ortega participated in sports and was on the traveling football team. Upon graduation, he chose to go to work in the meat-packing industry in Kansas City, and then discovered that he really needed to get an education.

Ortega attended Wayne State College in Wayne, Nebraska. While there he started a company of fellow student-athletes who cleaned houses to earn money for school. In addition, he joined the Nebraska National Guard and in his junior year, when the Korean War began, he joined the service as a corporal. He was identified for his leadership ability and was sent to Aviation Cadet School where he completed pilot

training. He received a commission in the Air Force as a second lieutenant and was selected to attend flight training in the P-51 Mustang fighter.

While he was in pilot training at Vance AFB, Oklahoma, Ortega met the love of his life, Shirley. They were married July 2, 1952, at Luke Air Force Base, Arizona, prior to him shipping off to Korea where he flew 50 combat missions in a P-51. His aircraft was named the "Spirit of Boys Town."

After the Korean conflict, Ortega remained in the Air Force, completed his

The BTNAA is soliciting your input for the following awards to be presented on July 27, 2013:

Father Flanagan Distinguished Alumni Award

This award is given to an alumnus who, by example throughout the years, has brought credit to themselves, their family, their community, Boys Town and our Alumni Association by serving others in a selfless and compassionate manner in the way that our founder, Servant of God Father Flanagan, did in his life. This award is the highest honor that can be bestowed on a Boys Town alumnus and is, therefore, given only to the most deserving persons. The award is presented at the banquet on Saturday of the Convention.

BTNAA - Alumni Appreciation Award (Non-Alumnus)

This award is given to a non-alumnus who, by example throughout the years, has brought credit to themselves, their family and their community, and is a consistent supporter by word and deed of our Alumni Association. This person is often a volunteer at the Hall of History or a member of the Boys Town staff who has gone out of their way to help the BTNAA in the work of the Association or in supporting the work that is required during the Biennial Conventions. This award is presented at the General Assembly meeting on Saturday morning.

BTNAA – Alumni Service Award (Alumnus)

This award is given to an alumnus who has shown extraordinary support and assistance to Boys Town and our Alumni Association. This award

recognizes the selfless efforts of our brother and sister alumni in helping the BTNAA accomplish its mission and in bringing together fellow alumni. This is a person who might volunteer at the Alumni Office in the Hall of History, work on BTNAA projects or in some very active way, provide a service to the BTNAA. This award is presented at the General Assembly meeting on Saturday morning.

BTNAA - Honorary President

This award is given to an individual (non-alumnus) who has shown evidence of good moral character, love of children, outstanding service in the community and love of God and man, and who will bring honor to our Association and to Father Flanagan's Boys' Home. This award is announced at the banquet on Saturday night.

BTNAA Hall of History Inductees

This recognition is given to up to five alumni who, through their life's work, contributions to their communities and support and involvement with the BTNAA, are worthy as being recognized by their brother and sister alumni by inclusion into the Hall of History. These inductions are made at the General Assembly meeting on Saturday morning.


July. The dates are July 25-28 and we look forward to seeing all of you there.

college education and retired as a lieutenant colonel, having flown bombing missions in Vietnam in the B-52 bomber. After the Air Force, he worked in a number of entrepreneurial ventures, founded a home for boys in California and worked as director of personnel at Boys Town.

Ortega remembers his first day at Boys Town, where he thought he was meeting the warden of the school in Father Flanagan's office. He was surprised when the priest opened a drawer and had him take some candy that he kept there for the boys. Ortega knew then that Boys Town was a special place. He

fondly recalls a time in the dining hall when Father Flanagan approached him and wished him a happy birthday in front of all the other boys.

The secret to 60 years of his successful marriage, according to Ortega, is that he was lucky enough to marry a wonderful woman and they never stopped needing each other.

Ortega has been very active with the Boys Town National Alumni Association on the Board and as president. Under his leadership, the BTNAA began the Lifetime Member program, and Joe is proud to hold member No. 2 as a BTNAA Lifetime Member.

The Ortegas have five children and 12 grandchildren. They all attended the celebration of their 60th wedding anniversary last summer.

After graduation, Schrantz took a Greyhound bus back to live with his foster

parents in Phoenix, Arizona. In July 1947, Schrantz enlisted for a three-year tour with the United States Navy, attending electronics school at the Great Lakes Naval Training Center in Illinois. Upon completion of his tour, he enrolled as a freshman at Notre Dame in South Bend, Indiana, only to be recalled to active duty for the Korean conflict.

After his second tour of duty, Schrantz went back to Notre Dame and met his bride to be, Dorothy O'Donnell of Chicago. They were married on November 19, 1953. Upon graduation from Notre Dame, armed with a degree in journalism, Schrantz

began his life work as a writer and editor. He is the author of 15 books that have been published by Infinity Publishing. He wrote a book about his 50th class reunion held at Boys Town in 1997.

While at Boys Town, Schrantz was assigned to work in Father Flanagan's rectory as an assistant to the cook, Sister Bertille. He helped serve meals, which were mostly always formal, to Father Flanagan, his sister and nephew, and many distinguished guests. For these events, Schrantz had a butler's uniform.

Schrantz's "secret" to a long marriage is to keep in mind at all times that, as the Church teaches, marriage is a lifetime commitment and that it is a give-and-take proposition. Attendance at Church is a large part of Joe and Dorothy's relationship with each other and with God.

Schrantz is a Lifetime Member of the Boys Town National Alumni Association.

He and his wife have seven daughters and one son. They have 23 grandchildren.

Nominations Sought for BTNAA Regional Board of Directors

Every two years, several BTNAA Board of Director positions are open for nomination. This year, there are four positions open for nomination and one At-Large position coming open that will be filled by the new Board of Directors.

Regions that will have open positions and the current Board Member are Region 2, Bo Rhudy, '61; Region 5, Chuck Ripple, D'68; Region 6, Carl Hegerty, '70; Region 8, Lisa Morehouse-Mabey. John Fox, '81, is presently filling the At-Large position to be appointed by the Board at the General Assembly meeting in July.

Nomination forms will be mailed to current members of the BTNAA to be returned by May 31. Ballots will be mailed prior to July 1.

Below is Article VI of the BTNAA By-Laws that governs the election of members of the BTNAA Board of Directors. If you have any questions, please call the Alumni Office at 402-498-1151 and speak with John Mollison, Senior Advisor for Alumni Matters. Election of Board Members is a privilege of membership and is important as your Board of Directors moves forward with its Strategic Plan for the future of the BTNAA and to increase membership and benefits for our members.

ARTICLE IV - NATIONAL BOARD OF DIRECTORS

- Section 1. **Powers.** Subject to grants of specific powers and authority made by these By-Laws to the members, the National Board of Directors shall control, formulate policy for, and administer the Association, and the National Board of Directors shall have all the powers and such authority as is necessary or incidental to performing such functions.
- Section 2. **Eligibility.** No person shall be eligible to be a director unless they are an active member.
- Section 3. **Number.** The National Board of Directors shall be comprised of not more than ten (10) directors.
- Section 4. **Selection.** The members of the National Board of Directors shall be selected in the following manner:
- (a) **Regional Directors.** There shall be eight (8) regional members of the National Board of Directors; that is, one from each of the following eight (8) regions:
- Region I: The states of Iowa, Kansas, Missouri, Nebraska, North Dakota, South Dakota.
- Region II: The states of Illinois, Indiana, Michigan, Minnesota, Ohio, Wisconsin.
- Region III: The states of Connecticut, Maine, Massachusetts, New Hampshire, New Jersey, New York, Rhode Island, Vermont.
- Region IV: The states of Delaware, Maryland, Pennsylvania, West Virginia, Virginia, and The District of Columbia.
- Region V: The states of Alabama, Florida, Georgia, Kentucky, Mississippi, North Carolina, South Carolina, Tennessee.
- Region VI: The states of Arkansas, Colorado, Louisiana, Oklahoma, New Mexico, Texas.
 - Region VII: The states of Arizona, California, Nevada, Utah.
- Region VIII: The states of Alaska, Hawaii, Idaho, Montana, Oregon, Washington, Wyoming.
- (b) **Nominations.** Nominations for Regional Directors may be made in the following four manners:
- (1) **Alumni Chapters.** Each Alumni chapter may nominate one active member of the Association for the position of regional director for the region in which the Alumni chapter is located and the nominee resides.

The secretary of the Alumni chapter must certify the nomination, and the nomination must be received by the national office on or before May 31 of the year in which the General Assembly is held.

- (2) **Members.** Any five (5) active members of the Association may nominate an active member for the position of regional director for the region in which the five (5) nominating members reside and the nominee resides. Each such nomination must; (a) be in writing and signed by the five (5) active members making the nomination; (b) be acknowledged by the nominee that he will serve, if elected; and (c) if mailed, be received by the national office on or before May 31 of the year in which the General Assembly is held.
- (3) **General Assembly.** General Assembly nominations will be accepted for a particular region only if the region failed to comply with the provision in the previous paragraph, Article N , Section 4, (b)
- (4). Only active members from within the affected region, personally in attendance at the General Assembly, may nominate a candidate to fill their regions vacancy on the Board, or to vote to endorse a candidate, if more than one candidate is available for the region.
- [5] **National Board of Directors.** If no nominations are forthcoming from the chapters or regions the National Board will have the authority to fill the position and will make every effort to fill it with a regional candidate.
- (c) **Election of Regional Directors.** The regional directors shall be elected by and from the active members residing in the respective regions. The secretary or National Board of Directors shall cause regional ballots to be printed, one for each of the regions, setting forth the name and address of each nominee for each respective region. The secretary or National Board of Directors shall cause the regional ballots to be mailed to each active member in each respective region at their address as shown on the records of the Association. Each such mailing shall:
 - (1) First Class Mail. Be by regular first class mail;
- (2) **Date.** Be made on or before July 1 of the year in which the General Assembly is held; and
- (3) **Secret Ballot.** Include a plain envelope marked "Ballot" in which the active member can place their ballot without disclosing their identity, and a separate return envelope addressed to the national office of the Association. The secretary of the National Board of Directors shall receive the ballots cast and hold same in the condition in which received until the General Assembly is convened, at which time the ballots shall be opened and tabulated in the presence of the General Assembly. In the event of a tie vote, the same shall be decided by the active members from that region in attendance at the General Assembly, and in the event no active member from that region is in attendance, the same shall be decided by the National Board of Directors immediately following the close of the General Assembly. In each instance in which the active members fail to elect a regional director, for whatever reason, the National Board of Directors shall make the election.

Section 5. **Directors-at-Large.** There shall be two (2) directors-at-Large. They shall serve staggered terms. At the General Assembly and once the eight (8) regional directors have been elected, the eight (8) regional directors and the at-large director whose term has not expired, shall submit nominations to the entire National Board of Directors, and upon secret ballot of the National Board of Directors, the nominee with the largest number of ballots shall be elected to serve on the National Board of Directors as director-at-large.

Section 6. **Term of Office.** The term of office of each regional director and each director-at-large shall be four (4) years, beginning at the close of the General Assembly at which his election is announced or made and ending at the close of the second General Assembly next succeeding.
